
1866-1933

Levi Sherman Hudelson was born in llinois about 1866. Levi- after his Brother-inlaw, and Sherman honoring the historic General under which his father William F. Had served in the war.

Relocating to Parker, Montgomery county Kansas with his parents prior to 1875 and purchasing a farm in Sedan, Chautaugua County, Kansas, about 1885 when 19 years old, he settled down in Sedan.

Selma's parents were from Sweden. Selma E. Anderson was born 1872 in Illinois according to the 1900 census. However, I remember her telling me about traveling to Oklahoma Territory via covered wagon. She lived in Coody's Bluff, Indian Territory where she apparantly met Levi.



Even though the birth records show all children being born in Coffeyville, 1900 census records have Levi's residence as Sedan. And Levi's occupation was Farmer. There was also a tenent at the Farm named William Crisman

Census of 1895 has Selma and Levi as well as the children living with William F. Hudelson in Coffeyville. After 1902 Selma and family lived at #12 E. 2nd in coffeyville. It, therefore, isn't much of a leap to assume they were living in William's house in the "Big City" while Levi worked the farm in Sedan with his tenent, William Crisman.

On Friday, 13 June 1902, Having had enough of Levi's absence, Selma sues for divorce. Apparanty granted, Levi S. Disappears to the farm in Sedan, and thereafter to Bryan, Okmulgee County, Oklahoma, there working in the oil fields, at least untill 1920.

Selma died 16 Feb. ,1964 and is buried at Fairview Cemetary, Coffeyville KS

In 28 December ,1912, Levi married Alberta Crowe, in Haskell, Oklahoma. There were another 2 children. A son, Guy Earl Hudelson in [b. 1907-before they were married- probably from a previous marriage, And Roy Hudelson [b.1914].

She died 9 Sept 1951, buried at Resthaven Memorial Park, Pottawatomie County, Oklahoma.
